**CORRIGENDUM – 2**

Please refer to our Tender Notice No VKGB/HO/A&S/2014-15/05 dated 27/05/2015 on  
“TENDER FOR PROCUREMENT OF UPS SYSTEMS AND BATTERIES AT  
BRANCHES / OFFICES OF VIDHARBHA KONKANI GRAMIN BANK” AND  
SUBSEQUENT CORRIGENDUM -1 DATED 15/06/2015.

Subsequent to the pre-bid meeting held on 23/06/2015, it has been decided to make  
following amendments in the tender. The interested bidder may submit their bids taking  
into consideration these amendments.

1. Tender under reference includes two parts i.e. tender for procurement of 2 and 3 KVA UPS systems and tender for procurement of batteries for existing UPS systems and buy-back of existing batteries. The cost of this combined tender is ₹. 5,000/-. Bidders can submit their bid for any of the tender or for combined tender. Two separate sealed envelopes are to be enclosed for each tender viz. technical bid and price bid.
2. Separate DDs towards EMD for 2 KVA UPS, 3 KVA UPS and Batteries can be submitted. EMD in the form of Bank guarantee of public sector Bank will be accepted. EMD has been reduced to 5% of procurement value instead of 10% proposed earlier. As per Govt. guidelines, exemption for tender cost and EMD is allowed provided supporting documents for registration under NSIC is enclosed.
3. SMF type of batteries is deleted from tender.
4. Isolation transformer should be specified as a part of UPS equipment.
5. Certification of C-10 batteries is necessary from OEM.
6. Where only bare batteries are to be quoted the make will be same as that specified in tender for UPS with batteries.
7. Minimum VAH for 2 KVA & 3 KVA UPS is fixed as 14040 and 21600 respectively.
8. Cost of Buy back price for existing batteries may be quoted on the basis of rating.
9. Replacement of existing UPS above the age of 5 years may be considered on case to case basis at the sole discretion of the Bank.
10. Prices are to be quoted separately for 130/150/180AH rating respectively.
